2. Main Focus and Questions (SS) 2.1 MAT Merge (SS)Attended a briefing session with the regional team this week. We assumed with our Good Ofsted and Good SIAMS that the merge would follow smoothly. A new regional Commissioner had been appointed with a lot of work to do. 80% secondary schools are in a MAT but only 49% of primaries. At the meeting we assumed llfracombe would be next on the list for transfer but we were told not yet – reason given – results this year, and another school being taken on. The St Christopher's Primary and Secondary MATs met last February and agreed in principle to merge. There will be further discussion at the Primary Members' meeting next week. (Ht) I understand now why we are not on the radar – we had good Ofsted, good SIAMS and a good education advisor report – we are not in 'need' or in a deficit situation, being properly lead and don't need any help in teaching and learning (PG) as a school where does this leave us? What can we do to safeguard ourselves in the meantime? (Ht) I am focused on raising standards and Managing the budget, staffing restructure raising attainment. (SS) we have a visit to the academy hopefully before the end of the school year.
